

# Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to **Dailybot** (<https://dailybot.co>), **Moli Market** (<https://moli.market>), **Bambú Meditation** (<https://appbambu.com>), **Lanzador** (<https://lanzador.co>), **Rocka Website** (<https://rocka.co>) and RockaLabs LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to RockaLabs LLC include RockaLabs, Dailybot, Bambú Meditation, Moli Market and Lanzador. The RockaLabs products are digital and offered as Software as a Service. By using any of the RockaLabs products, you consent to the data practices described in this statement.

## Collection of your Personal Information

RockaLabs may collect personally identifiable information, such as your:

- Name
- Address
- E-mail Address
- Phone Number

If you purchase RockaLabs's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction. Billing and credit card information are not stored by RockaLabs' products and services, and will be safely stored by certified payment partners as Stripe, Braintree and PayPal or by Mobile Application Platforms such as Apple Inc. or Google Inc. in the case of In-App payments.

Information about your computer hardware and software may be automatically collected by RockaLabs. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the RockaLabs website.

Please keep in mind that if you directly disclose personally identifiable information or personally sensitive data through RockaLabs's products public message boards, this information may be collected and used by others.

RockaLabs encourages you to review the privacy statements of websites you choose to link to from RockaLabs so that you can understand how those websites collect, use and share your information. RockaLabs is not responsible for the privacy statements or other content on websites outside of the RockaLabs website.

## Use of your Personal Information

RockaLabs collects and uses your personal information to operate its website(s) and deliver the services you have requested.

RockaLabs may also use your personally identifiable information to inform you of other products or services available from RockaLabs and its affiliates. RockaLabs may also contact you via surveys to conduct research about your opinion of current services or of potential new services that may be offered.

RockaLabs does not sell, rent or lease its customer lists to third parties.

RockaLabs may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to RockaLabs, and they are required to maintain the confidentiality of your information.

RockaLabs may keep track of the websites and pages our users visit within RockaLabs, in order to determine what RockaLabs services are the most popular. This data is used to deliver customized content and advertising within RockaLabs to customers whose behavior indicates that they are interested in a particular subject area.

RockaLabs will disclose your personal information, without notice, only if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on RockaLabs or the site; (b) protect and defend the rights or property of RockaLabs; and, (c) act under exigent circumstances to protect the personal safety of users of RockaLabs, or the public.

### **Use of Cookies**

The RockaLabs website may use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you, and can only be read by a web server in the domain that issued the cookie to you.

One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the Web server that you have returned to a specific page. For example, if you personalize RockaLabs pages, or register with RockaLabs site or services, a cookie helps RockaLabs to recall your specific information on subsequent visits. This simplifies the process of recording your personal information, such as billing addresses, shipping addresses, and so on. - SSL Protocol
